# A Fresh Start? A Conversation with Senator Warren's Staff on a Reimagining of Consumer Bankruptcy and of Third Party Releases 1.2 Credits Business Law

Senator Elizabeth Warren introduced legislation in 2021 that would dramatically change the process and rules surrounding consumer bankruptcy and in 2022 that would curtail third party releases in chapter 11 cases. The consumer bill would replace chapter 7 and chapter 13 with a new "chapter 10." Senator Warren's Counsel will join in a lively discussion on the consumer bill and on the bill restricting third party releases.
