



# The American College of Bankruptcy First Circuit Fellows and Boston College Law School present:

Recent years have seen a new surge in retail bankruptcies, featuring such familiar names as Eastern Mountain Sports, Radio Shack, Aeropostale, Pac Sun, Sports Authority, American Apparel and The Limited.

These bankruptcy filings are occurring amidst enormous changes in the retail industry, driven in large part by the rapid growth of internet retailing. Those changes, in turn, are having a profound impact on related businesses, including retail liquidations, private equity and real estate development.

To better understand these trends, this year's Symposium will present two panels. The first will be comprised of retail business leaders, sharing their insights on the business conditions that are driving retail trends. The second panel will consist of individuals who have played key roles in recent bankruptcies – including in the Aeropostale Chapter 11 – who will discuss how the business trends are shaping strategies in retail bankruptcy cases.
