

The Induction Ceremony and Annual Meeting of the College will take place March 7-8, 1997. Our Executive Director, Suzanne Bingham, and our Scholar-in-Residence, Leon Forman, have

spent a great deal of time and effort in making the arrangements for what will prove to be a wonderful occasion. For the first time, we will have an educational program followed by supper at the Metropolitan Club.

Suzanne Bingham has invited a number of honored guests to the Induction. We will not know for some time how many will accept, but the invitees include the Senators and members of Congress from the inductees' states, House and Senate Judiciary Committee Members and Staff, Supreme Court Justices and Supreme Court Justices' secretaries and law clerks, members of the Judicial Conference Bankruptcy Rules Committee, officials of the Administrative Office of the U.S. Courts, officials from the Bankruptcy Division, and Executive Office of the U.S. Trustee. The Induction will be held in the Great Hall of the Supreme Court, followed by a reception in the East and West Conference Rooms of the Supreme Court. The next day, at

# **All Fellows Meeting**

The Åll Fellows Meeting of the American College of Bankruptcy was conducted on Thursday, October 16, 1996, at the Marriott Hotel, San Diego, California. The meeting began with introductory remarks from Chair, Gerald Smith, who furnished a history of the College, mentioning the contributions of past officers, including Dick Gitlin, Hon. William L. Norton, Jr., Ed Creel, and Harry Dixon. Chair Smith stated that these officers were instrumental in the formation and growth of the College and that the College is now completely independent from the American Bankruptcy Institute.

Chair Smith then introduced Suzanne Bingham, Executive Director, who reported on the transition from the American Bankruptcy Institute, the induction ceremony scheduled for March 7, 1997, and various legislative matters. She reported that there will be press releases for matters pertaining to the College, as well as individual press releases for each of the 1997 Inductees.

Brady Williamson and Hon. Robert Ginsberg presented a report on the Bankruptcy Review Commission. Judge Ginsberg reported that Brady Williamson maximized the resources of the Bankruptcy Review Commission, obtained the funding for the Commission, and provided exemplary leadership for the group. Brady Williamson expressed the thanks of the Commission to Gerald Smith and Suzanne Bingham and special thanks for the submissions by Leon Forman, which Brady Williamson said were especially beneficial. Brady Williamson recommended that the College members become involved in the legislative process and elevate the level of interest of the legislators who have a desire to become involved in bankruptcy matters. He reported that the Commission would meet in San Diego during the week of October 16 and that the Commission had met for 1-1/2 days nearly every month and was making decisions every month. He indicated that the Commission has taken the position that a mandatory stop at the District Court is neither required by Northern Pipeline nor beneficial. The Committee will continue to spend a considerable amount of time on consumer bankruptcy and small business bankruptcy cases, including single asset cases. In response to a question from Hon. Leif Clark, Brady Williamson indicated that there may be changes recommended to the judicial training process and also changes suggested to the Rules. Ginsberg said the Committee has not yet decided what approach to take with regard to the Rules or judicial training. Leon Forman asked whether the Commission report might include recommendations on the operation of the United States Trustee system, and Brady Williamson responded that it might. Neal Batson said that Leon Forman had submitted the report of the College and Brady Williamson said that the Commission has already implemented some of the proposals. Neal Batson indicated that the College would therefore reinstitute the College Bankruptcy Review Commission Focus Groups and that the reports from the reinstituted Focus Groups would be due in March of 1997. In addition, the Focus Groups may be increased from six to eight to parallel the Commission Focus Groups. Neal Batson asked that those who have not yet served indicate a willingness to serve on these Focus Groups, especially those with experience and interest in consumer cases.

Peggy Sheneman reported on the work of the Budget Committee, stating that the goal is to make sure that the College members receive value for their dues. The members of the Budget Committee are Peggy Sheneman, Raymond Shapiro and Neal Batson. The expenses of the College include the administrative fees of the Executive Director, the induction ceremony and Spring Meeting in Washington, D.C., a limited contribution to the History Project, and the publication of the College Columns. Treasurer Sheneman also provided specific information on income and expenses, including incidental expenses for the Pro Bono Committee and the On-Line Committee. Treasurer Sheneman reported that, with the maturity of the organization, there will be an attempt to make every meeting self-funding.

Leon Forman reported on the educational program for the Spring Meeting, which will begin at approximately 9:00 a.m. on Saturday and continue until approximately 4:30 p.m.. The first presentation will be on Article 9 of the Uniform Commercial Code, focusing on the interrelationship between

Along with the College Fellows, inductees, their family members and guests, members of Congress from the inductees' states will be invited to the Induction ceremony. We currently anticipate not only having a web page with the most important bankruptcy resource bookmarks available, but additionally having the biographies of each of the Fellows accessible through the web. We anticipate having a "search engine" created so that anyone looking for highly specialized bankruptcy help will be able to access Fellows by state or name.

In addition, the web site will include a bulletin board, which all the Fellows can use regarding problems and questions which arise in our practice, and an ability to communicate with each other through the internet.

We are currently at a stage where we will be developing our web site as soon as we have funding from the College, and we remain optimistic that, by the time of the next All Fellows Meeting March 7-8, 1997, we will have it up and running. If things go well we will have a short instructional session at the meeting so that we will be ready to return home and to cyberspace.



## **Board of Directors Meeting**

A meeting of the Board of Directors of the American College of Bankruptcy was conducted on Thursday, October 16, 1996, at the Marriott Hotel, San Diego, California.

In attendance were Gerald Smith, Ray Shapiro, Peggy Sheneman, Merrill Francis, Neal Batson, Dick Gitlin, Ralph Mabey, Roger Whelan, Leon Forman, Hon. William L. Norton, Jr., Evelyn Biery, and Suzanne Bingham.

The minutes of the meeting of July 15, 1996, were unanimously approved as submitted.

There followed a discussion by Gerald Smith of the Induction at the Spring meeting of the College. He announced that the Induction is scheduled for Friday, March 7, 1997, at the Great Hall of the Supreme Court of the United States. Leon Forman then presented a report on the July 1996 meeting of the Education Committee and its plans for the Spring meeting.

There followed a discussion of sponsors for College events. Suzanne

Bingham announced that MB Valuations and College Fellow Les Miles had made a \$3,000 donation to the College. College Treasurer, Peggy Sheneman, reported that the Budget Committee will work on the on-line alternatives, because of the cost of each mailing for the College, which at present is \$2-2,500 per mailing. Peggy Sheneman said that the History Committee has been allocated \$5,000 per year for three years. There are admissions fees to cover some of the expenses of certain events, and the induction ceremony is covered by the induction fees. There are also substantial expenses related to meeting rooms and miscellaneous travel costs. Peggy Sheneman does not recommend increasing dues at this time, and she does not recommend paying dues for only a limited number of years. Of the members, 75 pay \$50 each and 150 pay \$250 each.

the UCC and the Bankruptcy Code. At present there is a Drafting Committee of the Permanent Editorial Board and NCCUSL considering very important changes to Article 9, including making it easier to obtain liens on all of the assets of debtors and also including provisions for deposit accounts in Article 9, a major change in the attitude of the Article 9 Committee. There has also been a suggestion that there be a carve out for the benefit of unsecured creditors and a change in the Bankruptcy Code to provide for a carve out. The second segment will be on bankruptcy strategies such as making an appeal moot and making exclusivity a critical factor in the case. The panel includes Harvey Miller, Leonard Rosen and Larry King and will be moderated by Barney Shapiro. There will also be reports on the work of the Bankruptcy Review Commission and a panel presentation that will include judges who have contributed to leading trends, such as mediation. Leon Forman asked that the Fellows make suggestions for the program.

Evelyn Biery reported on the work of the Publications Committee, indicating that the projects include the publication of the College Columns and the compendium of The Best of The Best. Leon Forman reported on the annual Distinguished Service Award, noting that he had forwarded written information to the members approximately two months prior to the All Fellows Meeting, listing the criteria for the award. He reminded everyone that the deadline for submissions is November 15, 1996.

Ron Martin reported that the On-Line Committee had sent out Internet addresses

and bookmarks. The Committee is looking at the possibility of a home page with a list of the Fellows and even pictures and résumés. Ron Martin asked that the members let him know their thoughts on whether they want a password.

Dick Gitlin reported on the Transnational Insolvency Program, a tremendous project headed up by Jay Westbrook and Bruce Leonard. The College has changed its bylaws to include memberships for Fellows from countries other than the United States. He reported that the World Congress of INSOL will meet in the United States in March of 1997, the first time the World Congress has ever been met in the United States. The World Congress will include bankers and other insolvency professionals.

The next program was presented by Mickey Sheinfeld, Don Bernstein and Susan Freeman. The discussion included the rules for court-appointed professionals. panel considered whether the rules should remain as they are or whether disinterestedness should be abolished, as well as whether the provisions regarding interests adverse to the estate should be expanded or defined. The Restatement of the Law Governing Lawyers was also discussed. Leon Forman noted that there was disagreement on the commentary rather than on the language of the Restatement itself. The panel considered whether the commentary rules should be amended to take into account the special nature of insolveny proceedings. Changes would include distinguishing bankruptcies from ordinary bilateral litigation.

There being no further business, the meeting adjourned.
