Nomination Procedures for Twelfth Class

In mid-April of 2000, Merrill R. Francis, Chair of the Board of Regents, wrote to each Fellow requesting that nominations, together with

▲ Merrill R. Francis biographical information and other supporting data, be forwarded to each Circuit Admissions Council by June 16, 2000. Fellows are reminded that the nominations should be complete and that substantial due diligence is required in order to make it likely that a candidate will receive an invitation; incomplete and insubstantial nominations are less likely to receive favorable consideration. It is imperative that nominees not be contacted. All names of nominees must be kept confidential! We want to avoid any potential embarrassment on the part of someone who may be considered but not extended an invitation.

Nominations for Judges should be forwarded to Leonard E. Gilbert (Chair, Judicial Nominating Committee), and nominations for Foreign Fellows should be forwarded to Daniel M. Glosband (Chair, Foreign Fellows Nominating Committee). Thereafter, each Circuit Admissions Council will review nominations received for that Circuit (other than Judges and Foreign Fellows) and begin the process of making recommendations to the Board of Regents.

Each Fellow within a Circuit will receive the names of the proposed Fellows in that Circuit (other than Judges and Foreign Fellows) and be asked to comment on each proposed Final Circuit Admissions Fellow Council recommendations and recommendations of the Judicial Nominating Committee and Foreign Fellows Nominating Committee will be forwarded to the Board of Regents, which will meet on Wednesday, October 18, 2000, in Boston, Massachusetts, in conjunction with the meeting of the National Conference of Bankruptcy Judges. Invitations to new Fellows for the Class of 2001 will be sent out in mid-November of 2000.

New Foreign Fellows

The Class of 2000 included five new Foreign Fellows from diverse professional and geographic settings. Representing the accounting, academic and legal professions, the Inductees come from as far as

New Zealand and Hong Kong to as close as Canada. By unplanned coincidence, all live in either England or parts of the former British Commonwealth.

Charles Booth is an American who graduated from Yale University and Harvard Law School but has been a faculty member at the University of Hong Kong since 1989. He now serves as Associate Dean and Associate Professor of Law. A prolific writer, editor and lecturer, his list of publications, lectures and professional activities fills nine single-spaced pages. Much of Professor Booth's writing and research focuses on transnational or "cross-border" insolvency, including articles on U.S., Chinese and Hong Kong laws. He has lectured in Japan, China, Singapore, Malaysia, the Philippines, Hong Kong and the U.S. and has developed a special expertise in Hong Kong insolvency law, its proposed reform and the effects of the 1997 transition to control of Hong Kong by China.

Yoine Goldstein is a native of Montreal who received his undergraduate and initial law degrees from McGill University, the latter with honors. He went on to receive a diploma in comparative legal studies and a doctorate (with great distinction) from the Université de Lyon. Since admission to the bar of Quebec in 1961, Yoine has been a member of the firm of Goldstein, Flanz and Fishman in Montreal and in 1993 served as special counsel to Olympia & York Development Ltd. in its simultaneous U.S. and Canadian reorganization proceedings. Bar and educational activities include Founding Director and member of the National Executive Committee of the Insolvency Institute of Canada, Founder and past Chairman of the Quebec Section on Bankruptcy of the Canadian Bar Association, Lecturer on Commercial Law and Bankruptcy and Insolvency at

Members of the College are encouraged to submit nominations to the Judicial N o m i n a t i n g Committee, particularly from locations

which are not well represented in the College. It is hoped that the membership will make an extra effort this year to seek out qualified candidates in these areas.

The Committee also wishes to call attention to applications which were submitted last year but which were not acted upon as the proposers need to update and supplement these applications to bring them current. If you wish to have the application considered again, please advise the Committee.

Without a complete application setting forth the accomplishments of the candidate in great detail, as is necessary with all membership applications to the College, it is difficult for the Committee to act upon a candidate. This, in turn, leads to disappointment by those who are proposing the candidate. This disappointment can be avoided if those preparing the application follow the bylaws and gather the information necessary to make a complete application. Even though the candidate cannot be informed that he or she is under consideration, there are a number of ways to obtain the information. This includes the biographical information submitted to CLE programs, listings in the directories of various professional organizations, and electronic searches with respect to their writings, to name a few of the possible sources.

Good solid letters of recommendation are always helpful, particularly when they describe the candidate's participation professionally based on facts. Simply saying "Judge ______ would make a wonderful member" is simply not enough! Finally, we do respect the deadline set by the Chair of the Board of Regents and ask that you have the completed application to the Judicial Nominating Committee by that date.

Once we have all the applications, the Committee will undertake to make personal contacts in the area, review the submittals and make such other investigations as may be appropriate.

Educational Program Spring 2000

The Educational Program at the Annual Meeting of the College was held on Saturday, March 18, 2000, at the Cosmos Club in

▲ Alan N. Resnick Washington, D.C. The program was stimulating, informative, and enthusiastically received by 150 Fellows who attended the event. It featured eleven exceptional speakers – divided into three panels – who discussed important areas of bankruptcy and insolvency practice. Each Fellow attending the program received a program book that included detailed outlines, articles, and other materials on the topics discussed.

The program began with a panel discussion of *Troubled Company Acquisitions*, featuring Robert J. White of O'Melveny & Myers; David G. Heiman of Jones, Day, Reavis & Pogue; and David L. Resnick of Peter J. Solomon Company. The speakers, who have a wealth of transactional experience in this area, discussed strategy and pitfalls relating to asset acquisitions from financially troubled companies. In particular, the panelists focused on break-up fees, section 363 sales, sales under a chapter 11 plan, and buying claims as a strategy for acquiring a company in bankruptcy.

The second segment consisted of a presentation on the emerging area of *Cross-Border Insolvency*. The international

panel of experts was chaired by Richard E. Broude and included Gerold Herrmann, Secretary of the United Nations Commission on International Trade Laws (UNICITRAL), Bankruptcy Judge Sidney B. Brooks of the District of Colorado, Professor Bruce A. Markell of the University of Nevada at Las Vegas School of Law, and Professor Ian F. Fletcher of the University of London's Queen Mary & Westfield College. These experienced and scholarly panelists treated the Fellows to an informative introduction to the proposed new Chapter 15 of the Bankruptcy Code which is included in the pending House and Senate bankruptcy reform bills. They also discussed the American Law Institute's project on cross-border insolvency, UNCITRAL's model law, the European Union Convention on Insolvency Proceedings, and the impact of these developments on the recognition of foreign proceedings and the methods for handling concurrent insolvency proceedings.

The final presentation, entitled *Hot Topics*, began with a brief update on the status of bankruptcy reform legislation, and then turned to a discussion of important recent judicial decisions. The speakers included three outstanding bankruptcy practitioners, Marcia L. Goldstein of Weil, Gotshal & Manges; Mark E. MacDonald of MacDonald & Schuble, LLP; and Charles P. Normandin of Ropes & Gray.

Preview of Educational Program for Fall 2000

The All Fellows Luncheon and Educational Program will be held on Wednesday, October 18, 2000, from noon until 2:00 P.M., at the Westin Copley Plaza Hotel in Boston, and promises to be an exciting and informative event. The topic for discussion will be "The Duty to Disclose Connections: How to Comply with Bankruptcy Rule 2014." The program will feature a panel of three distinguished experts, Hon. Mary F. Walrath, Bankruptcy Judge for the District of Delaware, Richard B. Levin of Skadden, Arps, Slate, Meagher & Flom LLP (Los Angeles), and Susan M. Freeman of Lewis & Roca LLP (Phoenix).

The speakers will discuss the duty of a professional to disclose connections with creditors, shareholders, other parties in interest, and the office of the United States Trustee, when seeking retention under section 327 or 1103 of the Bankruptcy Code.

There is widespread sentiment that a professional's obligation to disclose "connections" under Bankruptcy Rule 2014 is ambiguous and difficult to satisfy, especially in large cases with thousands of creditors and equity holders. Practitioners are especially concerned because of serious consequences that could result from a failure to comply with these disclosure requirements. The panelists will discuss the meaning of "connections" as that word is used in Bankruptcy Rule 2014. Is there a de minimis exception to the rule that all connections be disclosed? Suggestions and pitfalls regarding internal procedures used by medium and large firms in attempting to discover all connections, the duty to continuously monitor for conflicts, and the need to make supplemental disclosures during the case, also will be discussed. The panel also will comment on proposed rule amendments designed to improve Bankruptcy Rule 2014 and to make it more user-friendly for professionals. 🖷

The American College of Bankruptcy and the Biddle Library of the University of Pennsylvania School of Law entered into a historic agreement on

March 18, 2000, at the annual meeting of the College. The agreement outlines the formal establishment of the National Bankruptcy Archives. The College also sent a check for \$20,000 to the library to provide matching salary funds for the fulltime archivist who will be setting up this collection.

The College leadership has appointed Mary Scott, Leon Forman, Alan Resnick and Myron Sheinfeld to a planning committee which will propose protocols and structure for moving ahead with the National Bankruptcy Archives project. A larger advisory committee is envisioned which will ultimately serve as a formal liaison between the College and the Law Library. The planning committee will also develop protocols for the placement of the actual College archival materials (i.e., minutes, original copies of all newsletters, and any other appropriate records) as well as materials that come to the College from individual members and other organizations. Long range, this committee and the future advisory committee will be identifying and gathering appropriate archival materials from individual College members and others, including organizations working in the field of bankruptcy. The committee will actively work to assist the College in the creation of an Endowment to raise funds to insure the continued viability of the National Bankruptcy Archives.

We received the following Letter from the Dean of University of Pennsylvania, addressed to the College:

As the new Dean of the University of Pennsylvania Law School, I am tremendously excited about the opportunities that lie ahead. In these early days of my tenure, your dedication to Penn Law is especially meaningful to me. It is with great pleasure and pride that I thank you for your help in facilitating and establishing the National Bankruptcy Archives at the Biddle Library of the University of Pennsylvania Law School. The generosity of the American College of Bankruptcy, the National Conference of Bankruptcy Judges and the Association of Former Bankruptcy Judges has made it possible to established this important collection.

Millennium, Richard Broude, a College Fellow, will conduct a College-sponsored program on Mass Torts at St. John's University School of Law in Brooklyn, New York. This is the first time that a law school course has been directed solely to this critical area of the law, and the College will now be able to actively sponsor and participate in the nation's first L.L.M. Bankruptcy Program. Prof. Robert M. Zinman, a newly inducted Fellow, is the director of this L.L.M. Program and is responsible for developing St. John's University School of Law as a "leading pillar of identity" in the Bankruptcy arena. Prof. Alan Resnick, the College's scholar in residence, will be responsible for coordinating and assisting in the College's sponsorship role.

This L.L.M. program at St. John's University School of Law is not like the customary 24 credit masters program, but rather is a comprehensive and challenging program that requires 30 credits and the submission of a thesis on a current bankruptcy issue. Several members of the Masters Program Advisory Board at St. John's are active College Fellows, and based on the number of applications and students enrolled in the first class (September 1999) this L.L.M. Program should be one of the bright educational lights in the Millennium.

Our next step is the creation of an "extranet" to be used in conjunction with our webpage. What is an extranet, anyway? Well, it is a new tool for all the Fellows to be able to pose questions, give answers, post information for all of us. This tool has already been of tremendous use to in-house/outside lawyers who are working on massive cases. For example, Holland and Hart has set up a nationwide extranet for defense of all of the Phen-Fen cases, so that all counsel and clients can have the benefits instantaneously of new information as it develops. It is really a source of on-going knowledge management so that we can go to one place to capture all the best thinking and new materials in the bankruptcy field.

We will be starting it up soon as soon as Suzanne is able to complete a few pressing matters.

Pro Bono Committee Report

As of the date this column is being written, two additional grant requests are being circulated among Pro Bono Committee members for approval. The Consumer

Bankruptcy Assistance Project has received near-unanimous approval for a \$1,000 grant, and unanimous approval is anticipated for a \$1,000 grant to the Polk County (Iowa) Bar Association Volunteer Lawyers Committee.

Members of the Pro Bono Committee strongly encourage providers of pro bono bankruptcy services to submit grant requests. The one page form could not be easier to complete, and the process for approval is very simple to accomplish.

Yet we have had a relatively small number of applications since the inception of the College's Grant program.

Several organizations have contacted Committee members about grants; all of the organizations had appropriate qualifications to warrant grants, but, in spite of follow-up by Committee members, some worthy organizations have not yet submitted applications.

One of the qualifications for grant approval is that the organization seeking the grant have an educational need. The Polk County Volunteer Lawyers Project grant request has all of the attributes of an appropriate educational project. The application states:

Proposed Educational Program

The purpose of conducting this proposed educational program is to recruit and train volunteer attorneys in order to increase the number of clients who receive pro bono assistance in bankruptcy. In 1999, only twenty-three clients were represented through the Polk County Bar Association Volunteer Lawyers Project in bankruptcies. The goal of this training would be to recruit thirty additional volunteer attorneys specifically trained to represent clients in bankruptcy proceedings. The training would be at no cost for those attorneys who agree to accept two pro bono referrals over the next year. If this goal were achieved, the number of clients served

Minutes of Board Meeting Fall 1999

AMERICAN COLLEGE OF BANKRUPTCY BOARD OF DIRECTORS MEETING OCTOBER 6, 1999 APPROVED MARCH 17, 2000

A meeting of the Board of Directors of College was conducted the on Wednesday, October 6, 1999, at the San Franciso Marriott, San Francisco, California. Members of the Board of Regents were invited to attend the meeting and to participate in the discussion on the future of the College. The following were in attendance: Raymond L. Shapiro, R. Neal Batson, Barbara A. Everly, Myron M. Sheinfeld, David T. Sykes, Bettina M. Whyte, Evelyn H. Biery, Merrill R. Francis, John A. Barrett, Susan M. Freeman, Leonard H. Gilbert, Stuart E. Hertzberg, David A. Lander, Louis W. Levit, Hon. Ralph R. Mabey, Ronald M. Martin, Prof. Grant Newton, Jerome Shulkin, Paul M. Singer, Richard S. Toder, Hon. Roger Whelan, Leon S. Forman, William J. Perlstein, Daniel M. Glosband, Prof. Alan Resnick and Suzanne Bingham.

Merrill Francis, Chair of the Board of Regents, presented the report on the procedures for notifying those who are being offered membership in the College, stressing the need for confidentiality.

Daniel Glosband, Chair of the Foreign Fellows Committee, presented the report on the nominations for Foreign Fellows.

Leonard Gilbert, Chair of the Judicial Fellows Committee, presented the report on the nominations for Judicial Fellows.

Suzanne Bingham, Executive Director, reported that the Year 2000 Induction Ceremony will be at the Great Hall of the Supreme Court once again. The College is outgrowing the Cosmos Club and the Metropolitan Club; consequently, the College will seek a new place for the Spring 2001 meeting and dinner. At the Corcoran Gallery in March of 1999 there were 281 in attendance. For the educational program there were 142, for dinner 191, for the bus tour 22 and for the Holocaust Museum tour 52.

Leon Forman, Scholar-in-Residence, reported on the educational program. The registration was the highest ever. As of November 1, Prof. Alan Resnick will become the Scholar-in-Residence for the College. Because of uncertainties in the pending legislation, the planning for the March 2000 educational program will be postponed until closer to the meeting date.

On motion duly made and seconded,

Leon Forman was thanked for his outstanding service to the College of Scholar-In-Residence. The motion passed by unanimous vote.

David Sykes, Chair of the Pro Bono Committee, reported on three additional grants submitted for the approval of the board. He indicated there is funding for ten grants, there are two pending approval by the committee, and three more may be submitted in the near future.

On motion duly made and seconded, the board authorized, for the 1999-2000 year, the expenditure of \$5,000 for organizations providing pro bono services in the consumer bankruptcy area, with authority to the committee and the president to approve grants in excess of \$5,000 to deserving organizations and with particular emphasis on newly-organized programs.

Paul Singer suggested that the Fellows make recommendations for grants to pro bono organizations in their respective circuits and be involved in the award of the funds. David Sykes indicated he will also continue to work with the president to complete the allocation and distribution of the authorized expenditures for the 1998-1999 year. The information will be put on the College web site.

Ray Shapiro, Chair of the College, reported that the sponsorships have increased from prior years. He suggested the College use some of its funds to augment the educational program and to sponsor programs outside the College, in order to make it clear to the patrons and sponsors that they are making contributions to bankruptcy education in a large venue. Paul Singer suggested there might be a permanent endowment for the educational program.

Bettina White, Treasurer, provided the financial report of the College. She indicated the College has succeeded in its goal of having one year of operating expenses on hand.

On motion duly made and seconded, the budget, as modified, was approved.

On motion duly made and seconded, Charles Vihon was moved to emeritus status pursuant to the provisions of Article IV.6.c. of the College Bylaws.

Hon. Mary Davies Scott, Chair of the Bankruptcy History / Archives Committee, presented the report of the Committee, which has as its purpose retrieving and preserving historical papers, documents, books and other memorabilia related to the history of bankruptcy and insolvency. On motion duly made and seconded, the College (a) resolved to support the designation of the University of Pennsylvania as the official repository for the History/Archives Project and (b) authorized the officers of the College to negotiate a contract with the appropriate persons and entities.

Judge Scott reported that the National Conference of Bankruptcy Judges and the Association of Former Bankruptcy Judges have each approved a contribution of \$5,000 for the History/Archives project and recommended that the College sponsor a luncheon during the Year 2000 meeting of the National Conference of Bankruptcy Judges, with any net proceeds being donated to the History/Archives Project. The recommendation was taken under advisement, to be presented to the members of the College at the luncheon meeting.

On motion duly made and seconded, subject to any discussion at the luncheon meeting of the College, the board directed the officers to work with the National Conference of Bankruptcy Judges to sponsor a luncheon during the Year 2000 meeting, on a one-year trial basis, with any net proceeds to be donated to the History/Archives Project and with the details to be worked out between Neal Batson as president of the College and Judge Scott as incoming president of the NCBJ.

Hon. Ralph Mabey, Chair of the Liaison Committee, reported on the work of the committee. He indicated the committee favors working with Judge Scott on the luncheon sponsorship.

Evelyn Biery, Chair of the Publications Committee, reported on the work of the committee and the possible sponsorship of the *College Columns* by Matthew Bender/LEXIS Publishing.

Ray Shapiro, in the absence of Joel Piassick, reported on the work of the Directory Committee, indicating that the work on the directory was nearing completion.

Ray Shapiro, in the absence of Mickey Sheinfeld, reported that the focus groups on bankruptcy reforms will be reactivated and that Mickey Sheinfeld will continue to chair the committee.

Paul Singer, Chair of the Future of the College Committee, reported on the work of the committee. He indicated that the committee was appointed in April and that the membership of the committee represented a diverse group. The complete report of the committee is attached to these minutes as an addendum. [Because the full report was published in an earlier issue of the *College Columns*, only a synopsis will be reprinted here.]

Paul Singer reported that the median age of the College is 55.5 years and that the Future of the College Committee recommended that the College

- (a) Keep the same standards on membership as are presently in place but institute breakout sessions for Fellows to provide names of prospective Fellows at the meeting of the National Conference of Bankruptcy Judges;
- (b) Encourage circuits to have social or collegial meetings individually or together;
- (c) Conduct annual meetings, for the present time in conjunction with the meetings of the National Conference of Bankruptcy Judges;
- (d) Emphasize pro bono work, making it a permanent part of the College function;
- (e) Continue to publish the *College Columns* in hard copy to insure that Fellows of the College remain well informed;
- (f) Continue the educational program, including a history project;
- (g) Ensure that the name of the College is affixed to projects that are sponsored by or affiliated with the College;
- (h) Maintain the present model on educational programs;
- (i) Engage in outreach projects, in keeping with the mission statement of the College;
- (j) Explore, alone or in participation with others, a program regarding the electronic filing of bankruptcy pleadings; and
- (k) Maintain a permanent Future of the College Committee or a similar committee.

Neal Batson, President of the College, indicated he would work with Paul Singer to prepare a letter that would be forwarded to the membership of the College, along with the notification of the March 2000 meeting, to provide a report to the Fellows and to solicit the further recommendations of the Fellows.

Ray Shapiro recommended that the budget be modified by adding a \$5,000 amount for the Spring 2000 luncheon.

On motion duly made and seconded, the budget increase was approved.

On motion duly made and seconded, the minutes of the March 12, 1999 meeting of the board of directors were approved as corrected.

There being no further business to come before the meeting, the meeting was adjourned.

the University of Montreal, numerous articles on insolvency law topics and leadership positions with the Bar of Quebec. In addition, Yoine has been very active in community affairs and has received an award for outstanding volunteer leadership.

No doubt the only Fellow to have graduated from Pakuranga College and Auckland University, Paul Heath emigrated to New Zealand from Coventry, England, as a twelve year old. After three years as an Investigating Solicitor with the New Zealand Department of Justice, Paul joined the Hamilton firm of Stace Hammond Grace and Partners. where he specialized in insolvency, commercial litigation, arbitration and dispute resolution until he ended his association in 1998 to accept an appointment as Queen's Counsel. This honor necessitated the commencement of practice as "barrister sole." From July 1997 until May of 1999, law practice shared time with duties as a consultant to the New Zealand Law Commission responsible for projects on electronic commerce and cross-border insolvency. In May of 1999, Paul was appointed as a Commissioner of the Law Commission. He has been active in the New Zealand Law Society amd the International Bar Association, has been admitted as a Barrister of the High Court of Australia and has lectured and published in New Zealand, Canada, Australia and the U.S.

C. Garth McGirr, born in Niagra Falls, Canada, has been a chartered accountant since 1960 and an insolvency specialist since 1968. He rose in the Price Waterhouse ranks until he became head of the firm's national insolvency practice and a member of its worldwide Insolvency Advisory Group. Outside the firm. Garth was elected a Fellow of the Institute of Chartered Accountants of Ontario and also of the Canadian Insolvency Practitioners Association. Internationally, Garth was the first non-American to be elected as a Director of the American Bankruptcy Institute and is a past President of INSOL International. He has held numerous leadership positions in Canadian insolvency and accounting organizations, served as a member of the Licensing Board of the Superintendent of Bankruptcy and has been a frequent lecturer and author on insolvency matters. His practice has been highlighted by assignments to liquidate Canada's first failed bank since 1923, to liquidate a major property and casualty insurer and to advise the Government of Jamaica on reorganizing its financial sector.

Last among the year 2000 Foreign Fellows (by alphabet only) is Michael Steiner, the head of the Insolvency and Corporate Reconstruction group at London's Denton Wilde Sapte. A solicitor since 1964 and an insolvency specialist since the early 1970s, Michael's professional career includes representation of the administrators of Maxwell Communications Corporation, bondholders in the Barings Administration, the Department of Transport in the Olympia & York/Canary Wharf matter and the Czech Government on its insolvency legislation. He has been active in the Creditor's Rights and Insolvency Committee of the International Bar Association and the Society of Practitioners of Insolvency, has served as Chairman of the City of London's Solicitor's Society Insolvency Sub-Committee, has been an Adviser to the Russian Federal Ministry of Bankruptcy and has been a member of the Lord Chancellor's Insolvency Rules Advisory Committee.

This year's recipient of the American College Bankruptcy Distinguished Service Award is Gerald (Jerry) Smith.

Jerry was born in the State of Kansas and graduated from Kansas State University. He

received his law degree from NYU and upon graduation moved to Arizona and has practiced continuously with his law firm Lewis & Rocha. Jerry was an outstanding honor student both as an undergraduate and as a law student.

Anticipated Educational Program Costs

The cost of the educational program is divided into two parts. The anticipated cost of the Continuing Legal Educational Program is approximately \$500 which would be used for the distribution and printing of the registration brochure and printing of training materials. The second portion of the educational program expense is the purchase of bankruptcy software. The approximate cost of the West law software package is approximately \$500.
