Nomination Procedures for Fifteenth Class

mid-April of 2003, the Board of Regents will write to each Fellow requesting that nominations, together with biographical information and other supporting data,

be forwarded to each Circuit Admissions Council by June 15, 2003. Fellows are reminded that the nominations should be complete and that substantial due diligence is required in order to make it likely that a candidate will receive an invitation; incomplete and insubstantial nominations are less likely to receive favorable consideration. It is imperative that nominees not be contacted. All names of nominees must be kept confidential! We want to avoid any potential embarrassment on the part of someone who may be considered but not extended an invitation.

Nominations for Judges should be forwarded to Leonard E. Gilbert (Chair, Judicial Nominating Committee), and nominations for International Fellows should be forwarded to Daniel M. Glosband (Chair, International Fellows Nominating Committee). Thereafter, each Circuit Admissions Council will review nominations received for that Circuit (other than Judges and International Fellows) and begin the process of making recommendations to the Board of Regents. Please note that a Fellow can nominate a person who is not in the Circuit of such Fellow. If this is done it is very important that the completed nomination form be sent on time to the proper person pursuant to the bylaws.

Each Fellow within a Circuit will receive the names of the proposed Fellows in that Circuit (other than Judges and International Fellows) and be asked to comment on each proposed Fellow. Final Circuit Admissions Council recommendations and recommendations of the Judicial Nominating Committee and International Fellows Nominating Committee will be forwarded to the Board of Regents, which will meet on Wednesday, October 15, 2003, in San Diego, California, in conjunction with the Meeting of the National Conference of Bankruptcy Judges. Invitations to new Fellows for the Class of 2004 will be sent out in mid-November of 2003.

Nomination Procedures for Judicial Fellows

It is that time of year again. Now is the time to consider proposing for membership in the College the most qualified Bankruptcy Judge

before whom you have appeared. Do not wait for someone else to do it!

Often the Committee hears from one of our fellow members, "Why isn't Judge _____ a member of the College?" The answer usually is because no one has presented that nomination. There is more than one geographic area in this country that should have judicial representation in the College but does not. It is up to you, the members, to submit the nomination, and I encourage you to do so.

While the process for nominating a Judge is exactly the same as nominating a practicing attorney for membership in the College and the form and detailed information required is the same, it is, in fact, more difficult to present a Judicial Nomination. This is because you have to be able to obtain the necessary biographical data without letting the candidate know that he or she is under consideration. It is done every year, and I hope that more of you will consider doing so in 2003.

Through this past year for the Fourteenth Class, six members of the Judiciary were considered and approved for membership: Hon. Stuart M. Bernstein; Hon. Charles G. Case II; Thomas B. Donovan; Arthur B. Freedman; William H. Gindin; and Arthur J. Gonzalez.

This Committee is extremely hard working and diligent in their inquiry. They are to be congratulated for their efforts. Serving on the Committee are: James Baillie, Hon. Leif Clark, David Heiman, Hon. Barbara Houser, Prof. Kenneth Klee, Marc Levinson, Alan Miller, Barbara Rom, David Sykes and Leonard Gilbert.

Nomination Procedures for International Fellows

The International Fellows Nominating Committee started its consideration of candidates for the Class of 2003 with a prelim-

▲ Daniel M. Glosband inary list of nine names either carried forward from prior years or suggested during the course of the last 12 months. All preliminarily available information on those candidates was circulated to the Committee in early June, along with a request for additional suggestions. By the conclusion of the first conference call Committee meeting in late June, the potential list had two additional entries and a preliminary cut to four leading contenders. Nomination forms, in varying degrees of completeness, were assembled for the four and circulated for review prior to the second Committee meeting. The four contenders, Mr... Justice Adolfo Rouillon of Argentina, Thomas Benes Felsberg of Brazil, Christopher K. Grierson of England and a fourth who was ultimately deferred by the Board of Regents) became nominees. In addition, Jay Westbrook suggesgted a fifth candidate, Jacob S. Ziegel who became our fifth and final nominee. Messrs. Rouillon, Felsberg, Grierson and Ziegel have been invited to become Fellows.

Gathering information to complete nomination forms is usually difficult; for the International Fellows, it requires a higher degree of persistence and resourcefulness. As the process evolved, I sent a series of status reports on the several nominations, identifying incomplete components of each form and prodding Committee members to escalate their investigative intensity. All rose to the occasion and we were able to slide under the wire with our fifth and last form on August 22, 2002.

The nominees are each exceedingly impressive. Each is personally known to one or members of the Nominating Committee. Chris Grierson is a partner in Lovells' London office. He has had a major role in many of the best known cases of the 1980's and 1990's including Laker Airways, Barings and BCCI. He is an active member of IBA Committee J (and Vice-Chair) and the

International Insolvency Institute, has spoken and written for them and other organizations and has written for commercial publishers.

Thomas Felsberg is considered to be one of the most prominent insolvency attorneys in Brazil, active in several bar associations, debtor's counsel to Singer do Brazil and Outboard Marine Corporation and frequent author and speaker. Mr.. Justice Adolfo Rouillon of Argentina is a leading authority on Latin American insolvency. He has been involved in the World Bank project on insolvency law, has written seven books on insolvency law and over 100 articles. He also is on the faculty of two universities in insolvency and business studies.

Professor Jacob Ziegel is known to all of the Nominating Committee. In Jay Westbrook's words, "He is undoubtedly the best known and most revered commercial-law scholar in Canada and the leading academic expert on bankruptcy law ("insolvency") in Canada." In addition to writing over 100 books and articles, he was one of the two Canadian reporters on the ALI Transnational Insolvency Project (Bruce Leonard was the other). While he remains very active, he is retired from full time teaching and will be an Emeritus Fellows.

The members of the Nominating Committee are to be congratulated for their hard work and excellent results: Richard Broude, Evan Flaschen. Bruce Leonard, Dr. Hans-Jochem Luer, Prof. Grant W. Newton, Michael Steiner and Prof. Jay L. Westbrook.

tive addressed to bankruptcy law professors whereby the resources of the College were to be made available to law professors. The second project was to establish a pilot program whereby gifted bankruptcy students from three Circuits were to be invited to attend the annual meeting of the College in Washington, D.C. in 2002.

1. Law Professors Initiative

Letters were sent out from the Education Committee to over 300 professors in January 2002 advising them that if they had topics or questions which they wished to discuss, seek reactions to a particular idea, consider practical applications of a particular bankruptcy code section, or obtain a speaker for class discussions, members of the College were available to assist the professors. The response of the Fellows of the College was quite good and over 60 Fellows agreed to participate in the project. However, the response from the law professors has so far been non-existent. To my knowledge, there has not been a single inquiry from a law professor seeking assistance of any Fellow of the College.

In a conference call with the Education Committee in the Spring, discussion was had as to the reasons for the lack of success of the project and whether it should be abandoned. Possible reasons for inaction on the part of the law professors ranged from (i) lack of need (i.e., most professors already have sufficient informal contacts with the Bankruptcy Bar); (ii) overblown egos precluding use of a valuable resource; (iii) a sense that the resource was not all that valuable; and (iv) sloth. As for the question of whether to discontinue the project, there were decidedly mixed views. Some felt that the project was a failure, and we should accept it as such. However, others felt that in connection with the gifted law

Educational Program Spring 2003

The Educational Program at the Annual Meeting of the College in March 2003 promises to be another exciting and informative program. It will feature three panels of outstanding speakers, all prominent experts in their fields, discussing timely topics. The program will be held on Saturday morning, March 29, 2003, at the Mayflower Hotel in Washington, D.C.

The program will begin at 9:00 A.M. with a segment on Forum Selection: Factors To Consider When Deciding Where To File a Chapter 11 Petition. The presence of multiple venue possibilities often requires counsel to select the best forum for the particular chapter 11 case. The panelists have extensive experience in representing debtors in chapter 11 cases. The discussion will focus on the differences between the circuits on key substantive bankruptcy issues, as well as on procedural and practice considerations that counsel should consider when selecting the forum. The panelists will be Howard L.Adelman, of Gettleman, Merens, Berish & Carter, Ltd., Chicago; Marcia L. Goldstein, of Weil, Gotshal & Manges LLP, New York; Sally Schultz Neely, Esq., of Sidley, Austin, Brown & Wood, Los Angeles; and David T. Sykes, of Duane, Morris & Heckscher LLP, Philadelphia.

The second panel will be on *Bridging the Gap: Resolving Valuation Disputes In Chapter 11 Plan Negotiations*. Chapter 11 plan negotiations often boil down to a disagreement over total enter-

prise value or the value of specific plan securities. These issues will be debated against the background of multiple valuation methodologies, disputes over relative priorities and, ultimately, the legal requirement that the plan be fair and equitable to any impaired dissenting class. The discussion will focus on how creative plan design can help resolve these disputes and make a consensual plan possible. The panelists will be Donald S. Bernstein, of Davis Polk & Wardwell, New York; Michael A. Kramer of Greenhill & Co., New York; Frank A. (Terry) Savage of Lazard LLC, New York; and James H.M. Sprayregen, Kirkland & Ellis, Chicago.

The third panel discussion, entitled Hot Topics, will consist of a review and commentary on selected important and interesting recent judicial decisions of which all bankruptcy professionals should be aware. The panel will represent views from the bench, academia, and practice. The panelists will be Hon. Barbara J. Houser, United States Bankruptcy Judge, Dallas, Texas; Prof. Melissa B. Jacoby of Temple University Beasley School of Law, Philadelphia; Prof. Bruce A. Markell of the William S. Boyd School of Law, University of Nevada, Las Vegas, Nevada; and Brady C. Williamson, of LaFollette Godfrey & Kahn, Madison, Wisconsin.

The College will apply for appropriate CLE credit for Fellows who attend the Educational Program. As always, the Educational Program will be followed by the All Fellows Luncheon.

students pilot program, we should include in the letters being sent to the law schools a reference to the professors initiative. If there were responses, we would consider renewing the initiative; whereas, if there were no responses, the sentiment of the Committee was to inter this project. It was determined that the second approach would be adopted.

2. Law Students Initiative

As you will recall, the Directors decided to establish a pilot program to invite law students who had shown aptitude and commitment to the field of bankruptcy to the annual meeting of the College. Expenses would be paid by the College and every effort would be made

to involve the law students in the activities at the annual meeting. If the pilot program was successful, favorable consideration would be given to expanding the program.

In order to accomplish the mission, a letter has been sent to the Regents for the Second, Third, and Fourth Circuit councils requesting that they communicate with the law schools in their Circuit with a view towards the schools making recommendations to the Circuit as to the law students to be honored. In turn, the Regents of these Circuit Councils have sent letters to the law schools in their respective circuits requesting recommendations. The letters sent to the law schools reprise the law professors initiative.

The Committee met by conference call on April 24, 2002 and had a number of mail discussions. During the year the following grants were approved and funded:

- 1. Chicago Bar Association, Bankruptcy Committee, Pro Bono Subcommittee (Requested \$1,000)
- 2. Los Angeles Public Counsel law Center (Requested \$10,000)
- 3. Neighborhood Legal Services Association, Pittsburgh Pennsylvania (Requested \$2,500)
- 4. The Miller Center For Public Interest Advocacy, The Pennsylvania State University, The Dickinson School of Law (Professors Peter Alexander And Gary Gildin) \$10,000
- Coalition For Consumer, Bankruptcy Debtor Education, Pilot Program (Professors Karen Gross and Susan Block-Lieb) \$10,000

During the year the Committee continued to discuss (i) the inability to source grant applications; and (ii) whether the Committee should restrict grants to large grants that have a more meaningful impact and/or smaller grants which will effect more people but in a very limited way.

On the first issue the Committee requested that the Board consider approving and funding a program by which grants can be solicited through advertisements such as in the ABI Journal, etc. Insofar as the latter issue is concerned, the current consensus (not without dissent) is that to fulfill our mission of distributing allotted funds to worthy projects, it is necessary to make both large and small grants.

National Bankruptcy Archives Committee Report

In February, 2002 this Committee reported to the American College of Bankruptcy Board of ▲ Hon. Mary Davies directors that it was continuing efforts to

encourage the placement of bankruptcy and insolvency materials at the University of Pennsylvania School of Law Library. The Committee reported that the Library has received papers from Ken Klee and the papers of Professor Lawrence P. King. It also reported that some 100 file boxes of materials from the US. Bankruptcy court in the Southern District of New York comprising non-official court records covering many of the mega cases filed in the 1980's in that district were ready to be shipped to the Library. In addition, boxes of materials from Judge Robert Martin of Madison, Wisconsin, were also ready to ship. Both of these donations were referred to Suzanne Bingham in order that arrangements could be made for payment of shipping costs through the College. To date, however, these materials have not yet reached the library as was earlier reported.

In August, 2002 the chair of this Committee spent one week in Philadelphia working in the law school library and, more specifically, inventorying the 53 boxes of materials received from the estate of Professor Lawrence P. King. 43 of the boxes were inventoried (several pages of the contents of these boxes are attached as examples of the significant bankruptcy materials included in this collection). The boxes of correspondence were haphazardly packed necessitating a complete resort. Much of the correspondence to and from Professor King dated more than 20 years ago and contained onion skin copies made using carbon paper. Two additional follow up trips to the Law Library are planned for later in the fall in order to complete the inventory of Professor King's papers as well as the papers of the National Conference of Bankruptcy Judges.

The Fellows attending the meeting expressed interest in having a spring meeting in Kentucky - Lexington since there are four Fellows there?- and with this email are requesting that the Kentucky Fellows explore the possibility of such a meeting which might be expanded to include the entire circuit given the somewhat central location of Lexington. Speeches at the meeting were relatively short with the president pro tem of the Tennessee Fellows expressing concern over the fact that most of the members of the local bankruptcy bar did not have a clue as to what the College was all about, if they had even heard of it, thus frustrating the ability of the College to hold out their Fellows as examples for the bar. In an initial step to remedying this Sally Bailey had the dean of the VU law school at the conclusion of a bankruptcy program there the following week advise the audience that the College was the honorary organization which recognized outstanding bankruptcy attorneys and judges and had him introduce the Fellows there. We have considered it in the past but in the future it appears that we should invite the deans and/or bankruptcy professors of the appropriate law schools to our dinner meeting. What do you all think?

During the week in Philadelphia, the Committee Chair also met with the new Director of the Biddle Law Library, Paul George. It was a brief and cordial visit as Mr. George had only just arrived to take on his new assignment. He expressed his enthusiasm for the National Bankruptcy Archives project. We agreed to meet again later in the Fall to discuss proposals for sinage in the law library (which would reveal publically that the NBA is housed there) as well as a formal "unveiling" of the NBA. With regard to this last item, it was hoped that an event/reception could be planned in the Spring of 2003. After discussions with Mr. George as well as the archivists at the library, it was determined that the Fall of 2003 would be a better time. This later time suggestion will also allow for the complete inventory of the archival materials of the National Conference of Bankruptcy Judges. Materials located Washington D.C. have not yet bee shipped to the NBA, but that should be accomplished by the end of this year.

The visit in August also revealed that other College members, as well as bankruptcy judges have been sending papers to be included in the National Bankruptcy Archives. Murry Drabkin, Harvey Miller and Merrill Francis have all sent materials.

Finally, a reminder will be sent to Matthew Bender Lexis/Nexis in mid-November regarding the second installment of the five year, \$25,000 per year, grant to provide a matching salary amount for the library archivist.

In Memory of Hon. Frank Koger

The Honorable Frank W. Koger, United States Bankruptcy Judge for the Western District of Missouri and Chief Judge of the Bankruptcy Appellate Panel for the Eighth Circuit Court of

Appeals, died January 3, 2003, after a brief illness. He was 72. Before Judge Koger was appointed to the federal bench in 1986, he was a well known and respected commercial lawyer in Kansas City, Missouri, where he was a life long resident. He received his B.A. from Kansas City University in 1951 with Distinction and his L.L.B. from that university's School of Law in 1953,

where he graduated first in his class and was editor of the Law Review. Judge Koger also received a Master of Laws degree in 1965 from the University of Missouri at Kansas City. From 1953 to 1956 he served in the United States Air Force as a Staff Judge Advocate.

During his 30 years of practice and his almost 16 year tenure on the bank-ruptcy bench, Judge Koger was an active volunteer in community and professional organizations. He was elected president of the Commercial Law League of America in 1983 and, in 1995, he was presented with its Field Award of Commerce, only the seventh time that a member had received the award in the 41 years it had been established. Proposed Amendments to the College Bylaws

Following our March 2002 meeting, I have discussed with

▲ William J. Perlstein John Barrett proposed amendments to the Bylaws to reflect several matters discussed at the March meeting. The bylaws will be considered at the Annual Meeting of the College on March 29, 2003. The changes that we are proposing are as follows:

1. Length of Term of Regents. The bylaws (Article VII, Section 2) currently provides that a regent serves for a term of three years, and can serve a maximum of two consecutive threeyear terms. The consensus view was that the three-year term is too long and that regents serving six years consecutively was ill-advised. We considered either a single four-year term or two two-year terms. We settled on recommending two two-year terms for the reason that, if the regent were found after a year or two to be ineffective or inattentive, a four-year term could be a significant problem. The proposal is to amend Article VII, Section 2 to provide for a two-year term, and a maximum of two consecutive two-year terms.

2. Length of Term of Circuit Council Members. The bylaws (Article VIII,

Section 2) provide that circuit Council members serve three-year terms; there is no limit on the number of terms that they may serve. We recommend amending the bylaws to provide the same term length and limits as we are proposing for Regents. The proposal is to amend Article VIII, Section 2 to provide for a two-year term, and maximum of two consecutive two-year terms.

3. Sponsor Applications for election of Fellows. The bylaws (Article IV, Section 3, paragraph 2) provide that a Fellow sponsor must reside in the same circuit as a candidate that the Fellow is sponsoring. It appears that this provision may not have been adhered to in all cases, and in any event it appears unnecessary that a Fellow sponsor reside in the same circuit as a candidate that the Fellow is sponsoring for admission to the college. We recommend allowing a Fellow to sponsor a candidate to any Circuit Admissions Council, and requiring that at least one of the two Fellows who second the nomination maintain his or her principal office in the Circuit of the candidate. The proposal is amend Article IV, Section 3, paragraph b, to eliminate the requirement that a sponsor have his or her principal office in the same circuit as a candidate but to add that at least one of the two Fellows seconding the nomination maintain his or her principal office in the same circuit as the candidate.

4. Voting by Members of the Board of Regents. A question has been raised whether a Regent may vote on the nomination of a candidate for which that regent was a sponsor or cosponsor. Our view is that this should be allowed; otherwise a candidate could be prejudiced by the fact that a Regent knew him or her well enough to be a sponsor or cosponsor. The proposal is to amend the last two sentences of Article IV, Section 3, paragraph g. to provide that "A Member of the Board of Regents may not vote or participate in the consideration of a nomination of a partner, business or professional associate or relative of that Regent. The Board of Regents may not nominate or elect a Fellow on its own initiative but a Regent who was a sponsor or cosponsor of a candidate may participate and vote on the nomination of such candidate."

Hendel be asked to serve a second term as Regent from the First Circuit; (b) Richard J. Mason be asked to serve as the Regent from the Seventh Circuit; (c) Hon. A. Thomas Small be asked to serve as the board member from the Fourth Circuit; and (d) Lawrence K. Snider be asked to serve as the board member from the Seventh Circuit. The Board thanked Hon. Roger W. Whelan, Louis W. Levit and Gerald W. Munitz for their past service as the board member from the Fourth Circuit, the board member from the Seventh Circuit and the Regent from the Seventh Circuit, respectively.

On motion duly made and seconded, the Board of Directors approved the submission of the names of the Hon. A. Thomas Small to serve as the board member from the Fourth Circuit and Lawrence K. Snider as the board member from the Seventh Circuit.

On motion duly made and seconded, the Board authorized Prof. Grant Newton and Joel Piassick to purchase directors and officers insurance in an amount in excess of \$1 million and fidelity insurance in an amount in excess of \$1 million.

On motion duly made and seconded, the Board resolved that the signatures of two officers of the College will be required for the withdrawal or transfer of any funds from the accounts of the College at Merrill Lynch and Morgan Stanley.

On motion duly made and seconded, the Board resolved that the initial directors of the American College of Bankruptcy Foundation will be Hon. Glen E. Clark, Leonard H. Gilbert, Stuart Hirshfield, Joel P. Kay, Joel B. Piassick, M. Freddie Reiss, Hon. Mary Davies Scott, Raymond L. Shapiro and David P. Sykes, and that the College will donate \$75,000 plus the induction fees for the 2002-03 year, approximately \$28,400, to the American College of Bankruptcy Foundation after the Foundation is approved as a Section 501(c)(3) corporation by the Internal Revenue Service.

On motion duly made and seconded, the Board approved the budget for the 2002-03 fiscal year, as amended.

On motion duly made and seconded, the Board approved the financial statements, as amended.

The Treasurer reported that the dues of all Fellows are current.

John Barrett, Chair of the Board of Regents, presented the report on the selection of Regents and Circuit Council Members of the College and the invitees for the Thirteenth Class of Fellows. In early November 2001, letters were forwarded to all Fellows asking them to submit nominations to John Barrett for Fellows, to Daniel Glosband for International Fellows, and to Leonard Gilbert for Judicial Fellows.

Daniel Glosband, Chair of the International Fellows Committee, reported on the work of the Committee and indicated that the Committee will seek additional members who have international contacts and experience.

Leonard Gilbert, Chair of the Judicial Fellows Committee, reported on the work of the Committee and, in particular, its endeavors to ensure that nominations for judges include all required information.

Evelyn Biery, Chair of the Meetings and Events Committee, reported that ten regional meetings had been held in various areas around the country and fifteen are planned for the coming twelve months.

Ray Shapiro, Chair of the Distinguished Service Award Committee, reported that the recipient of the award for the 2001-02 fiscal year will be Hon. William L. Norton, Jr.

Suzanne Bingham, Executive Director, reported that the probable date for the 2003 Spring Meeting of the College will be March 28-29, 2003.

Evelyn Biery, Chair of the Publications Committee, reported that the next issue of the *College Columns* will be published at or about the same time as last year.

Prof. Alan Resnick, Scholar-in-Residence, provided a preview of the educational programs to be presented at the College All Fellows Meeting the following day, at the International Fellows Committee Meeting on the same day, and at the Joint Luncheon of the College and the National Conference of Bankruptcy Judges on October 2, 2002. He then presented a pro-

posal for the College to sponsor a Supreme Court review project in which the College will publish, perhaps with the assistance of a legal publishing company, an analysis of bankruptcy-related United States Supreme Court decisions from the past century in the form of a monograph. He reported that he would approach LEXIS-NEXIS for assistance with the project and Hon. Mary Davies Scott and Prof. Kenneth Klee had agreed to work on the project.

On motion duly made and seconded, the Board authorized the expenditure of \$25,000 to Prof. Kenneth Klee in the form of an honorarium for preparing the monograph. The Board also authorized Prof. Klee to approach Lexis-Nexis with a request that it assist with the cost of printing and distributing the monograph.

In the absence of Hon. Mary Davies Scott, Chair Neal Batson reported on the work of the National Bankruptcy Archives Committee.

Paul Singer, Chair of the Future of the College Committee, reported on the work of the Committee.

Gerald Smith, Chair of the College History Committee, reported that there would be a meeting of the History Committee later in the day.

David Sykes, Chair of the Pro Bono Committee, reported on the programs that have received funds from the College and indicated that Paul Singer is proposed to be the new Chair of the Pro Bono Committee.

Ron Martin, Chair of the Online Committee, reported that the Extranet will be more than a chat room and can be a great resource for posing questions to be discussed among the Fellows of the College. In addition, the Committee is working on the Extranet case share programs and also on a portal system that will provide information that will allow telephone hookups and calendar functions and certain other tools. The Extranet will also have the capacity for threaded conversations.

Raymond L. Shapiro presented the report of the Nominating Committee as to new Regents to be submitted to the membership of the College later in the day and noted that the various circuit councils will be appointed by the Chair of the College. He also reported that Jerry Smith will serve as an ex officio director of the College because of his past service to the College.

There being no further business to come before the meeting, the meeting was adjourned.

the larger community. The National Bankruptcy Archives established by the College at the University of Pennsylvania Law School as a national repository of archival materials relating to the history of debtor and creditor relations, continues to prosper. Matthew Bender/Lexis Nexis has provided a \$25,000 annual matching salary grant for five years in honor of Professor Lawrence P. King to help fund the salary of a professional archivist for the Archives. In March of 2002, we announced a multiyear project for analyzing the bankruptcy decisions of the United States Supreme Court during the last century. One of our Fellows, Professor Kenneth N. Klee, has agreed to undertake this effort on behalf of the College. In October, 2002, Matthew Bender/Lexis Nexis agreed to underwrite the cost of printing, binding and distributing approximately 8,000 copies of the manuscript to the members of the bench and bar. Three outstanding law students from the Second, Third and Fourth Circuits will join us at the annual meeting in March as part of a pilot program of the College designed to identify and encourage the development of future insolvency professionals. The Pro Bono Committee of the College has been particularly active during the last several years through its sponsorship of various courses at law schools and sup-

port of legal assistance programs. Specifically, we have sponsored undergraduate and graduate courses in business and consumer bankruptcy at St. John's University School of Law, the University of Alabama School of Law and the University of California, Davis School of Law, which have been taught by distinguished members of the College. In addition, the support of neighborhood justice centers has included the "Fresh Start Clinic" in Philadelphia, the "Put Something Back" project in Miami, and similar programs in Tucson, Arizona; Rochester, New York; Des Moines, Iowa; Seattle, Washington; Chicago, Illinois: Pittsburgh, Pennsylvania; and the State of New Jersey. We continue to support the Coalition for Consumer Bankruptcy Debtor Education Pilot Program in New York. None of these outreach programs would have been possible without the funding provided by our Patron and Sponsor program. More than 90 firms contributed approximately \$500,000 to this program during the last three years. In addition, in the spring of 2002 we created the American College of Bankruptcy Foundation for the purpose of promoting and funding the pro bono, educational and other charitable projects of the College. To date, the Foundation has been funded in an amount exceeding \$100,000.

By March 2003, the History of the College committee will complete its work on the College history. We are also developing a role for the College in the legislative arena, not as lobbyist or proponent of legislation, but to provide education for those legislators and staffers involved in the legislative process. The establishment of the Liaisons Committee of the College in March 2001, has enabled us to work with the National Conference of Bankruptcy Judges and other organizations in collaborative efforts to improve our profession.

While much has been accomplished, much remains to be done. We are a unique organization of practitioners, academics, judges and public servants who are among the best in our profession. Together we have a rare opportunity to socialize and learn from the best the insolvency profession has to offer while filling our obligation to "put something back" into the larger community.
