## Join us in Tampa for a Special Presentation: "Afghanistan: A Country In Transition"

As the world becomes increasingly smaller, we are looking forward to a very special presentation by Hon. Michael G. Williamson, U.S. Bankruptcy Court in Tampa, Florida. He will be speaking at the All Fellows Luncheon to be held on October 12, 2011 in Tampa, FL. Judge Williamson will speak about the development efforts to create a commercial law system that has been going on in Afghanistan since 2007. These efforts include the creation of microfinance and small-to-medium enterprise lending; drafting of laws on secured transactions, mortgages, and leasing; and the implementation of the laws. He will also discuss the ongoing process of drafting and implementing a bankruptcy law in a country with no effective commercial court system and the challenges faced by development specialists working in a Sharia-based legal system in the midst of an ongoing armed conflict.
